De bhun cheanglais na reachtaíochta thuas, tugtar fógra leis seo maidir leis an togra chun an fhorbairt seo a leanas de chuid Chomhairle Contae Átha Cliath Theas a thógáil:

Fótavoltachas gréine ar an díon agus córas teaschaidéil a shuiteáil ag SDC Leisure Thamhlachta, Bealach Bhaile Uí Fhoirtcheirn, Tamhlacht, Baile Átha Cliath 24, D24KX38.

Is éard atá i gceist leis na hoibreacha atá beartaithe ná:

- Eagar fótavoltach gréine ar an díon a shuiteáil, le limistéar measta 496m2, mar aon le hoibreacha suímh gaolmhara.
- Córas teaschaidéil a shuiteáil, atá comhdhéanta de 3 Theaschaidéal Aerfhoinsé 90kW, i limistéar charrchlós SDC Leisure Thamhlachta, mar aon le hoibreacha suímh gaolmhara. Beidh an córas teaschaidéil timpeallaithe ar thrí thaobh ag bacainn fhuaimiúil 2.4m ar airde agus ar an taobh eile fál 2.4m. Is é toise an limistéir fáilaithe ná 16.73m x 5.47m.
- 4 Chrann a bhaint chun an córas teaschaidéil a éascú.

Rinneadh Scagadh Measúnachta Cuí ar an moladh i gcomhréir le hAirteagal 6(3) den Treoir um Ghnáthóga (92/43/CEE) agus Scagadh do Mheasúnacht Tionchair Timpeallachta faoi Threoir MTT 2011/92/AE, arna leasú ag Treoir 2014/52/AE.

I gcomhréir le halt 81 na Rialachán um Pleanáil agus Forbairt, 2001, arna leasú, rinne an tUdarás Pleanála an cinneadh seo a leanas:

- (a) Ní dócha go mbeidh éifeachtaí suntasacha ag an bhforbairt bheartaithe, ina haonar nó i gcomhcheangal le pleananna agus tionscadail eile, ar leasanna cáilitheacha, ar chaomhnú speisialta nó ar chuspóirí caomhnaithe aon Láithreáin Eorpaigh ainmnithe. Dá bhrí sin, ní gá Measúnacht Chuí Chéim 2 a dhéanamh.
- (b) Ní dócha go mbeadh tionchar suntasach ag an bhforbairt bheartaithe ar an gcomhshaol agus ní forbairt í den chineál atá leagtha amach faoi Sceideal 5 de na Rialacháin um Pleanáil agus Forbairt, 2001, arna leasú, agus níl gá le TMMT dá réir sin.

Tá cinneadh déanta ag an údarás freisin faoi Airteagal 6(3) den Treoir um Ghnáthóga (92/43/CEE) nach mbeidh éifeachtaí suntasacha dóchúla ag an bhforbairt bheartaithe, ina haonar nó i gcomhcheangal le pleananna agus tionscadail eile, ar leasanna cáilitheacha, ar chaomhnú speisialta nó ar chuspóirí caomhnaithe aon Láithreáin Eorpaigh ainmnithe.

Is féidir le haon duine, laistigh de 4 seachtaine ó dháta foilsithe an fhógra seo, iarratas a dhéanamh chuig an gCoimisiún Pleanála ar chinneadh scagtha i dtaobh an dócha go mbeadh tionchar suntasach ag an bhforbraíocht ar an gcomhshaol.

Beidh pleananna agus sonraí na forbartha beartaithe ar fáil lena n-íniúchadh ar líne ar shuíomh gréasáin thairseach comhairliúcháin phoiblí na comhairle (<http://consult.sdblincoco.ie>) idir an 20 Iúil 2026 agus an 17 Lúnasa 2026.

Beidh sonraí agus pleananna priontáilte na forbartha beartaithe ar fáil lena n-íniúchadh nó lena gceannach ar tháille nach mó ná an costas réasúnach a bhaineann le cóip a dhéanamh ag Halla an Chontae, Tamhlacht, Baile Átha Cliath 24, le linn uaireanta oifige ón **20 Iúil 2026 go dtí an 17 Lúnasa 2026.**

NOTICE OF PROPOSED DEVELOPMENT BY A LOCAL AUTHORITY
PART 8 PUBLIC NOTICE

Pursuant to the requirements of the above, notice is hereby given of the proposal to construct the following development by South Dublin County Council:

Installation of rooftop solar PV and heat pump system at SDC Leisure Tallaght, Fortunestown Way, Tallaght, Dublin 24, D24KX38.

The proposed works comprise:

- Installation of a rooftop solar PV array with an estimated area of 496m2, with associated site works.
- Installation of a heat pump system, comprising of 3 No. 90kW Air Source Heat Pumps, in the car park area of SDC Leisure Tallaght with associated site works. The heat pump system will be surrounded on three sides by a 2.4m high acoustic barrier and on the remaining side by a 2.4m fence. The dimension of the fenced area is 16.73 m x 5.47m.
- The removal of 4 No. Trees to facilitate the heat pump system.

The proposal has undergone Screening for Appropriate Assessment in accordance with Article 6(3) of the Habitats Directive (92/43/EEC) and Screening for Environmental Impact Assessment under the EIA Directive 2011/92/EU, as amended by Directive 2014/52/EU.

In accordance with Article 81 of the Planning & Development Regulations 2001, as amended, the Planning Authority has made a determination and concluded that:

- (a) The proposed development, either individually or in combination with other plans and projects, will not result in likely significant effects on the qualifying interests, special conservations or the conservation objectives of any designated European Site. A Stage 2 Appropriate Assessment is therefore not required.
- (b) The proposed development would not be likely to have significant effects on the environment and that the proposed development is not of a class set out under Schedule 5 of the Planning and Development Regulations 2001, as amended, and therefore the completion of an EIAR is not required.

The authority has also made a determination under Article 6(3) of the Habitats Directive (92/43/EEC) that the proposed development, either individually or in combination with other plans and projects, will not result in likely significant effects on the qualifying interests, special conservations or the conservation objectives of any designated European Site.

Any person may, within 4 weeks from the date of publication of this notice, apply to An Coimisiún Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.

The plans and particulars of the proposed development are available for inspection online on the council's public consultation portal website (<http://consult.sdblincoco.ie>) during the period from **20th of July 2026 to 17th of August 2026.**

Printed plans and particulars of the proposed development are available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy at County Hall, Tallaght, Dublin 24, during office hours from **20th of July 2026 to 17th of August 2026.**

Submissions or observations with respect to the proposed development dealing with the proper planning and sustainable development of the area in which the proposed development will be situated may be made in writing up to **31st of August 2026** and may be submitted as follows;

Submissions should state the name, address, and, where relevant, details of any organisation, community group or company etc. which you represent. Only submissions received as set out above will be considered. It should be noted that the Freedom of Information Act, 1997-2006 (as amended) applies to all records held by South Dublin County Council.
