NOTICE OF PROPOSED AMENDMENT NO. 1 TO THE BALLYCULLEN – OLDCOURT LOCAL AREA PLAN (2014)

Notice is hereby given, pursuant to Section 20(1) of the Planning and Development Act, 2000 (as amended) that South Dublin County Council, being the Planning Authority for the County has prepared a **Proposed Amendment No. 1 to the Ballycullen – Oldcourt Local Area Plan (2014)**.

A **Strategic Environmental Assessment Screening Report** has been prepared and the Proposed Amendment No. 1 has undergone **Appropriate Assessment Screening** under the Habitats Directive (92/43/EEC). It has been determined that a Strategic Environmental Assessment and Appropriate Assessment are not required to be carried out for the Proposed Amendment No. 1.

The public consultation will take place from **15th December 2016 to 9th February 2017 inclusive**.
