

TRAFFIC RAMPS – 2019-2020

Public Consultation - Report

South Dublin County Council, under Section 38 of the 1994 Road Traffic Act, proposed several locations for the installation of traffic ramps. The proposed locations were advertised in National & Local papers, displayed in the Council office in Tallaght and Clondalkin and in all the libraries in the county and promoted on Facebook and Twitter. The period for public consultation was 1 month from 13th December 2018 to 14th January 2019. In addition, the proposed locations were marked with paint on the road to alert local residents to the exact location of the proposed ramps.

64 submissions were received on the Public Consultation Portal and 15 by post bringing the total number of submissions to 79. Of these 1 was late, 2 were duplicates, 2 were invalid and 4 were referring to locations not listed as part of the programme. Total of 70 eligible submissions.

Following analysis of the submissions, of 126 ramps proposed 31% were rejected. The following locations will NOT be proceeding with installation of ramps due to objections from residents.
