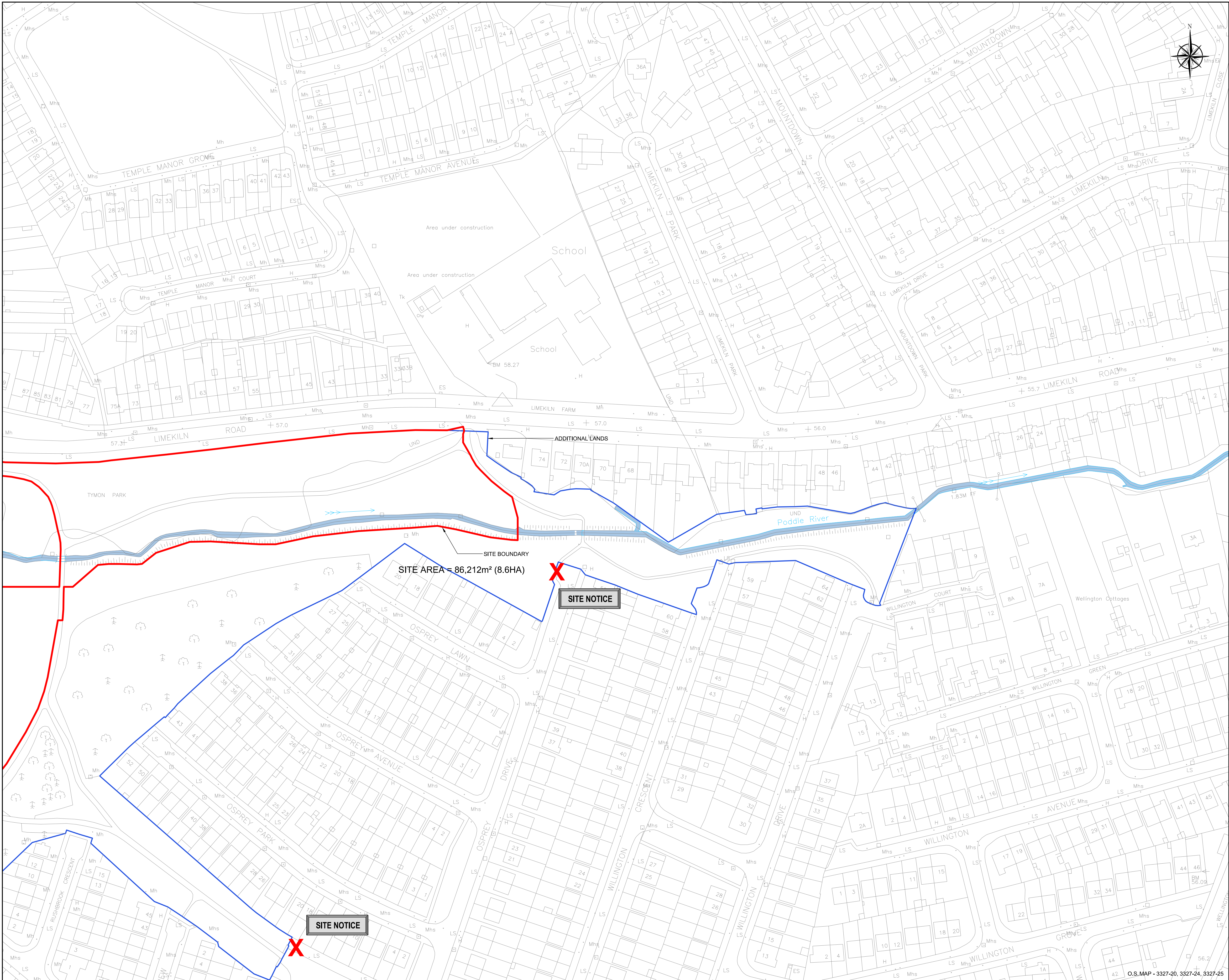
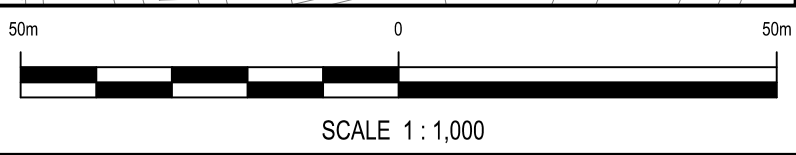




1 Site Location Map - Sheet 3
